Since these projects are to be undertaken simultaneously, NBP seeks to build its short-term capacity by engaging the services of a competent consulting firm/ three resources e.g. Competent Technical Source, Financial Cum Public Procurement Rules Expert and one Support Staff for handling documents who have similar project experience and a demonstrable track record in managing such technical projects in the public sector is essential for managing services of this nature. Bidder should be minimum 3 years of experience in providing same services as mentioned above. Photocopies of relevant documents / certificates should be submitted as proofs of the claims made. NBP reserves the right to verify / evaluate the claims made by the vendors independently. Only the bidders, who fulfill the above mentioned criteria, are eligible to submit their proposals.

Interested vendors may collect the bidding documents/RFP from undersigned office on or before **23rd August 2011**, after submitting a Non-Disclosure Agreement valid for 5 years (specimen of NDA may be obtained from the undersigned office), on production of Copy of CNIC and Authority Letter. Bids may be submitted accompanying all requisite documents by **27th August 2011 at 1000 Hours** in the office of undersigned. Tenders will be opened on the same day at 1030 Hours in the presence of bidders or their authorized representative. All bids must be accompanied by a bid security of not less than 2% of the total bid value, in currency of Pak Rupees.
