## SECTION I: INVITATION TO BIDS

National Bank of Pakistan (NBP) invites sealed bids from original manufacturers / authorized distributors / suppliers, registered with Income Tax and Sales Tax Departments and who are on Active Taxpayers List of the Federal Board of Revenue (FBR) for Supply & Installation of 5-KW Hybrid Solar Power System for NBP Toot Oil Field Branch (1601) OGDCL Project Branch Mardan.

The invitation for Bids is open to all prospective suppliers, manufacturers or authorized agents/dealers subject to any provision of incorporation or licensing by the respective national incorporating agency or statutory body established for that particular trade or business. (share copy)</li> <li>ii. Bidder should be regular tax payer registered with income tax &amp; sales tax departments and must appear on active list of FBR. (share copy)</li> <li>iii. Bidder should have Dealership Certificate to sell the offered product. (share copy)</li> <li>iv. 	4.2	For purposes of this Clause, "origin" means the place where the goods are manufactured, through 'manufacture, procession, or assembly.
5. One Bid per Bidder	5.1	A bidder shall submit only one Bid, in the same bidding process.

6. Cost of Bidding	6.1	The Bidder shall bear all costs associated with the preparation and submission of its Bid, and the National Bank of Pakistan shall in no case be responsible or liable for those costs, regardless of the conduct or outcome of the bidding process.

	7.3	The Bidder is expected to examine all instructions, forms, terms and specifications in the Bidding Documents. Failure to furnish all the information required in the Bidding Documents will be at the Bidder's risk and may result in the rejection of his Bid.
8. Clarification of Bidding Documents	8.1	A prospective bidder requiring any clarification of the bidding documents may notify National Bank of Pakistan in writing or in electronic form that provides record of the content of communication at National Bank of Pakistan's address indicated in the BDS, at least one week before the bid opening date.
9. Amendment of Bidding Documents	9.1	Before the deadline for submission of Bids, National Bank of Pakistan for any reason, whether at its own initiative or in response to a clarification requested by a prospective Bidder or pre-Bid meeting, may modify the Bidding Documents by issuing addenda.

### C. PREPARATION OF BIDS

15. Bid Prices	15.1	<p>Bid Prices quoted by the Bidder in the form of Bid and in the Price Schedules shall conform to the requirements mentioned in the bidding documents.</p>
	15.2	<p>Deliverables must be listed and priced separately in the Price Schedule(s). If a Price Schedule shows items listed but not priced, their prices shall be construed to be included in the prices of other items.</p>
	15.3	<p>Items not listed in the Price Schedule shall be assumed not to be included in the Bid.</p>
	15.4	<p>Prices quoted by the Bidder shall be fixed during the Bidder's performance of the contract and not subject to variation on any account. A Bid submitted with an adjustable price will be treated as non-responsive and shall be rejected.</p>
	15.5	<p>Bidder shall indicate on appropriate price schedule, the unit price and total bid price of the deliverables under the contract.</p>
16. Bid Currency	16.1	<p>Bidders shall quote prices in PKR</p>
17. Bid Validity Period	17.1	<p>Bids shall remain valid for 180 days after the Bid submission deadline prescribed by NATIONAL BANK OF PAKISTAN. A Bid valid for a shorter period shall be rejected as non-responsive.</p>

	17.2	Under exceptional circumstances, prior to the expiration of the initial Bid validity period, NATIONAL BANK OF PAKISTAN may request the Bidders consent to an extension of the period of validity of their Bids only once, for the period not more than the period of initial bid validity. NBP's request and the Bidders response shall be made in writing or in electronic form that provide record of the content of communication.
18. Bid Security	18.1	Bidder shall furnish as part of its Bid, a Bid Security amounting to <b>Rs.25,000/-</b> , in form of Bank Draft OR Bank Guarantee. Original Bid Security instrument <b>MUST BE</b> submitted to the under signed before online submission deadline of the bid.

	18.3	Unsuccessful Bidders' Bid Security will be promptly discharged.
	18.4	The successful Bidder's Bid Security will be discharged upon the Bidder signing the contract, and furnishing Performance Guarantee, as per SBD.
	18.5	Bid Security may be forfeited: a) if a Bidder: i) Withdraws its bid during the period of Bid Validity as specified by NATIONAL BANK OF PAKISTAN, ii) Does not accept the correction of errors b) in the case of a successful Bidder, if the Bidder fails: i) To sign the contract ii) To furnish performance security (or guarantee)
19 Alternative Bids by Bidders	19.1	Alternatives bids will not be considered.
20. Withdrawal, Substitution, and Modification of Bids	20.1	Before bid submission deadline, any bidder may withdraw, substitute, or modify its Bid after it has been submitted by sending a written notice, duly signed by an authorized representative, and the corresponding substitution or modification must accompany the respective written notice.
21 Format and Signing of Bid	21.1	Bid shall be typed or written in indelible ink and shall be signed by the Bidder or a person or persons duly authorized to sign on behalf of the Bidder. This authorization shall consist of a written confirmation as specified and shall be attached to the Bid. #### **D. SUBMISSION OF BIDS**

22. Sealing and Marking of Bids	22.1	The bidder shall submit electronic bids as per the requirements of e-procurement systems EPADS.
	22.2	In case of Single Stage Two Envelopes Procedure, the bid shall comprise two bids submitted electronically simultaneously, one called the "Technical Proposal" and the other "Financial Proposal."
23. Deadline for Submission of Bids	23.1	Bids must be submitted electronically through EPADS as specified in the BDS for ITB not later than the date and time intimated by NBP
	23.2	The National Bank of Pakistan may, at its discretion and as per PPRA Rules, extend this deadline for the submission of Bids by amending the Bidding documents in accordance with ITB 9, in which case all rights and obligations of the National Bank of Pakistan and Bidders previously subject to the deadline will thereafter be subject to the deadline as extended.
24. Late Bids	24.1	Any Bid received by the National Bank of Pakistan after the deadline for submission of Bids prescribed by the National Bank of Pakistan will be rejected.
25. Modification or Withdrawal of Bids	25.1	The bidder may modify or withdraw its bid after submission, through EPADS prior to the deadline prescribed for bid submission. Revision of bid may be submitted electronically through EPADS after withdrawal of original bid before the deadline of submission of bid. No bid may be modified after the deadline of submission of bids. No bid may be withdrawn in the interval between the bid submission deadline and the expiration of the bid validity period specified in ITB. Withdrawal of a bid during this interval may result in the forfeiture of the bidder's bid security.

#### **E. OPENING AND EVALUATION OF BIDS**

Opening of Bids	26.1	26.1 NBP shall open electronically through EPADS all technical proposals for all packages, excluding withdrawals, in public, in the presence of bidders' representatives who choose to attend, at the time, on the date and at the place specified in the BDS. Clarification of Bids	28.1	To assist in the examination, evaluation and comparison of Bids and post-qualification of the Bidders, the National Bank of Pakistan may, at its discretion, ask any Bidder for a clarification of its Bid including breakdown of prices. Any clarification submitted by a Bidder that is not in response to a request by the National Bank of Pakistan shall not be considered.
	28.2	The request for clarification and the response shall be in writing or in electronic forms that provide record of the content of communication.
29. Preliminary Examination of Bids	29.1	<p>Prior to the detailed evaluation of Bids, the National Bank of Pakistan will determine whether each Bid:</p> <p>a) meets the eligibility criteria</p> <p>b) has been prepared as per format and contents defined by National Bank of Pakistan in the Bidding Documents;</p> <p>c) has been properly signed;</p> <p>d) is accompanied by required securities; and</p> <p>e) Is responsive to requirements of the Bidding Documents.</p>

	29.2	<p>A substantially responsive Bid is one which conforms to all the terms and conditions of the Bidding documents without material deviations. 31. Correction of Errors	31.1	<p>i) Bids determined to be substantially responsive will be checked for any arithmetic errors. ## **8. Delivery**

Supply & Installation of 5-KW Hybrid Solar Power System are to be delivered within 2-4 weeks of the signing of the contract. Part payment against part delivery is not allowed.

## **9. Documents (GCC Clause 13)**

Upon delivery of the Goods, Supplier shall notify National Bank of Pakistan and mail the following documents to the National Bank of Pakistan:

- i. One original plus four copies of the Supplier's invoice showing Goods' description, quantity, unit price, and total amount;
- ii. Delivery Challan
- iii. Warranty certificate;

## **11. Payment (GCC Clause 17)**

Payment for Goods and Services supplied shall be made in Pakistani Rupees, as follows:  
**On Delivery & Acceptance:** 100% of the delivered stock or Contract Price (as agreed in contract) shall be paid to the Supplier within thirty (30) days after the date of the acceptance certificate for the delivery issued by National Bank of Pakistan.

## **12. Prices (GCC Clause 18)**

## **14. Resolution of Disputes (GCC Clause 29)**

1. If any dispute of any kind whatsoever shall arise between the National Bank of Pakistan and the Supplier in connection with or arising out of the Contract, including

without prejudice to the generality of foregoing, any question regarding its existence, validity, termination and the execution of the Contract- whether during developing phase or after their completion and whether before or after the termination, abandonment or breach of the Contract - the parties shall seek to resolve any such dispute or difference by mutual diligent negotiations in good faith within 7 (seven) days following a notice sent by one Party to the other Party in this regard.

2. At future of negotiation the dispute shall be resolved through mediation and mediator shall be appointed with the mutual consent of the both parties.
3. At the event of failure of mediation to resolve the dispute relating to this contract such dispute shall finally be resolved through binding Arbitration by sole arbitrator in accordance with Arbitration Act 1940. The arbitrator shall be appointed by mutual consent of the both parties. The Arbitration shall take place in Karachi and proceedings will be conducted in English language.
4. The cost of the mediation and arbitration shall be shared by the parties in equal proportion however both parties shall bear their own costs and lawyer's fees regarding their own participation in the mediation and arbitration. However, the Arbitrator may make an award of costs upon the conclusion of the arbitration making any party to the dispute liable to pay the costs of another' party to the dispute.
5. Arbitration proceedings as mentioned in the above clause regarding resolution of disputes may be commenced prior to, during or after delivery of goods.
6. Notwithstanding any reference to the arbitration herein, the parties shall continue to perform their respective obligations under the Contract unless they otherwise agree that the National Bank of Pakistan shall pay the Supplier any monies due to the Supplier.

- i) In consideration of the covenants and agreement to be kept and performed by the contractor, and for the faithful performance of this contract, and the completion of the work embrace therein, according to the specifications and conditions herein contained and referred to or agreed to in course of subsequent negotiations and in accordance with the general agreement and conditions of contract the National Bank of Pakistan shall pay, and the Contractor shall receive and accept as full compensation for everything furnished and done by the Contractor under this Agreement, the contract price stipulated in the Contractor’s Tender or such other sums as may be ascertained in accordance with such conditions of Contract etc. and at rates quoted against each item of work and agreed to accept by the parties as one instrument, and at the time and in the manner prescribed by the Conditions of Contract.
