

**REQUEST FOR EXPRESSION OF INTEREST FOR
PROCUREMENT OF CONSULTANCY SERVICES**

National Bank of Pakistan invites tax registered, experienced and competent consultancy firm / company to submit Expression of Interest (EOI) for procurement of Consultancy services, to find out causes of failure of existing Reverse Osmosis Desalination Plant installed at NBP Head Office Building, Karachi in a transparent manner in accordance with Procurement of Consultancy Service Regulations 2010.

Objective and Scope:

The scope of services required; but not limited to; are given as under:

- 1) Review, inspect and check the design, capacity and equipment/machinery of installed Reverse Osmosis Desalination Plant to confirm that it was installed as per BOQ specifications to provide the desired output/results as mentioned therein.
- 2) To determine as to what extent the equipment/machinery/system was installed in accordance with BOQ specifications then what were the causes/reasons of failure of Reverse Osmosis Desalination plant i.e. not been able to deliver desired quantity/quality of water.
- 3) To ascertain that after making any modifications / alterations the installed plant would become functional. Necessary consultancy and estimate to be submitted
- 4) In case, existing Plant cannot be made operational to meet NBP requirements, then prepare and submit a feasibility report for a new cost effective Reverse Osmosis Desalination Plant which could be installed at NBP Head Office Building, Karachi to fulfill NBP needs without dependence on any outsource water tanker arrangement

Eligibility Criteria

The following eligibility criteria for selection of consultancy firm/ company shall be followed:

S.No.	Terms & Conditions	Yes or No
1	The Consultancy firm / Company should submit its complete profile including organization structure, date of establishment, copy of certificate of Incorporation or registration.	
2	The Consulting firm / Company must be active tax payer and must provide NTN Certificate, Sindh Revenue Board Certificate and documents evidencing constitutional status.	
3	The Consulting firm / Company must have satisfactory financial position and should provide annual financial accounts of last three years.	
4	The Consulting firm / Company should submit an undertaking on a stamp paper that it is not blacklisted before by any bank/financial institution.	
5	The Consultancy firm / Company must have competent team/personnel having adequate qualification and relevant experience in Pakistan to carryout said assignment (Submit resume of appropriate personnel)	
6	The Consultancy firm / Company should have relevant experience of either providing consultancy services or have installed a successful Reverse Osmosis Desalination Plant (minimum 60,000 GPD production with around TDS of 300 PPM from underground raw water having TDS around & above 35000 PPM) in Pakistan during last five (05) years and should provide list of clients/installations with satisfaction certificates and their contact details.	
7	The Consulting firm / Company must submit an undertaking alongwith relevant documentary evidence that it is in relevant business for at least five (05) years.	

Ineligibility: NBP shall not allow any consortium to execute this project nor allows the Consulting Firm / Company to sublet the project either fully or partially.

Guidelines for submission of EOI

In order to qualify for the next stage, the Consulting firm / Company must meet the above stated eligibility criteria. The Consulting firms / Companies fulfilling the defined criteria are requested to submit their Expression of Interest along with necessary documents (including confirming their compliance to above stated criteria which reflects their capabilities and expertise required for desired works.

Expression of Interest shall be submitted to the undersigned not later than 17/05/2016. Shortlisted firms qualifying as per above stated eligibility criteria will be contacted for submission of Technical and Financial Proposal. Pursuant to Regulation-3 (A) Methods of Selection of Consultants of "Procurement of Consultancy Services Regulations, 2010" of PPRA, Quality Based Selection will be adopted for the selection of consultant.
