

## **TENDER NOTICE**

### **CASH IN TRANSIT SERVICES**

National Bank of Pakistan (NBP) seeks bid proposals from reputable Private Security Companies for “CASH IN TRANSIT SERVICES” for its Pan Pakistan Branch Network (37 Business Regions) and 340 ATMs (Off-Sites). The Service Provider will be responsible for “**Secure Collection, Transit and Delivery**” of Currency Notes from/to NBP Branches in **Cash in Transit Armored Vehicles**.

All interested companies having 5 years relevant experience of Banking Industry (enlisted with min 4 banks / PBA) will be entitled to participate in tender process. Further, they should have specialized vehicle fleet (minimum 100 vehicle), integral technical support/ logistic set ups in Karachi, Sukkar, Lahore, Faisalabad, Rawalpindi, Peshawar. Companies having valid registration certificate of sales/ income tax and enrolled in Active Tax Payer List (ATL) can only participate in tender.

The interested parties can obtain the Bidding Documents after paying tender cost of Rs.1000/- in shape of Payment Order (Non-refundable) in favor of NBP from the office of the “the Wing Head – Stationary, Transport and Engineering Procurement Wing, 3<sup>rd</sup> Floor, NBP Head Office, I.I. Chundrigar Road, Karachi on any working day during office time till **16<sup>th</sup> December 2019**.

This is a “Single Stage, Two Envelopes bidding Procedure” as per Rule 36(b) of PPRA 2004. The single package should contain two separate sealed envelopes. Each envelope should contain separately the Technical Proposal and the Financial Proposal. Both envelopes shall be marked as in bold and legible letters. The Sealed bids completed in all aspects, duly signed and company stamped (with name, designation) by the authorized person, should be dropped in the Tender Box placed in the Conference Room of the Divisional Head, Property & Procurement Division, 3<sup>rd</sup> Floor, Logistic Support Group, NBP, Head Office, Karachi on Tender opening date i.e. **17<sup>th</sup> December 2019 till 11:00 a.m.** If office remains closed for any reason, the tender will be opened on next working day at same time. For clarification of bidding document pre-bid meeting/session will be held on **6<sup>th</sup> December 2019 at 11:00 am**.

As per PPRA Rules the Sealed Tender(s) for Technical Evaluation will be opened on same day i.e. **17<sup>th</sup> December 2019 at 11:30 a.m.** by the Tender Opening Committee and in presence of representative of parties, who wish to be presented at the time of tender opening.

The Bank reserves the right to reject all bids or proposal at any time/stage prior to acceptance of tender and shall incur no liabilities as per Rule 33 of PPRA, 2004
