2. Copy of valid PEC Registration Certificate (Category C-5 or above) with code CE-10 & EE04 as mandatory.
3. Having experience of firm not less than 10 years as on date.
4. Registration Certificate with income tax (NTN) and other provivincial tax departments.
5. Completion certificate of works of similar nature from clients with minimum cost of project of Rs.15 Million or above.
6. Work order of projects of similar nature in hand with minimum cost of project of Rs.15 Million or above.
7. Technical capacity of the proposed staff including CV's to handle the assignment successfully.
8. Status of administrative, operational and financial capacity of the firm.
9. Audited financial statements of the firm for the last 3 years.
10. Bank Account Statements of the firm for the last 2 years.
11. Litigation history & black listing of firm (if any).
12. No litigation / black listing certificate on stamp paper.

After evaluation, only the pre-qualified firms shall be issued tender docuemnts which can be submitted up to **08-01-2019 on 11:00 A.M**, and shall be opened on the same day at **11:30 AM** in the office of the undersigned in the presence of the contractors who wish to attend.

An earnest money amounting to 2% of the tender amount in the shape of CDR from any scheduled bank in the name of undersigned must accompany each tender.
