National Bank of Pakistan intends to invite open competitive bidding as per PPRA Rule 36 b "**Single Stage Two Envelopes**" for the above work from contracting firms or Joint Venture firms comprising of Contracting and designing firms having valid registration with Pakistan Engineering Council (PEC) & Pakistan Council of Architects and Town Planners (PCATP) respectively and are registered in FBR and Provincial Sales Tax Boards. The Scope of work shall include complete architecture, interior design and execution of Civil, Electrical / Networking & plumbing works.

Only reputable firms registered with PEC & PCATP & fulfilling any one of the following criteria may apply for bidding documents;

- a) **The Contractors/ Firms applying for serial No. 1,2 & 3 having Registered with Pakistan Engineering Council in Category "C-5" or above" (Codes CE10 & EE4) & having in-house expertise of Architectural designing Sections equipped with PCATP registered qualified architects, will be eligible to apply for tender document.**
- b) **The Contractors/ Firms applying for serial No. 4 & 5 having Registered with Pakistan Engineering Council in Category "C-6" or above" (Codes CE10 & EE4) & having in-house expertise of Architectural designing Sections equipped with PCATP registered qualified architects, will be eligible to apply for tender document.**
- c) **Contracting Firms, which lacks the in-house Architectural designing Sections expertise may apply in Joint Venture with any PCATP registered firm.**
- d) **Consulting Firms may apply in Joint Venture with any PEC registered contracting firm having specialization fields of CE10 & EE04.**

Bidding documents, containing detail terms and conditions, method of procurement, procedure for submission of bids, bid security, bid validity, opening of bid, evaluation criteria, clarification / rejection of bids, performance guarantee etc. are available for the interested bidders at the office of Chief Engineer, Engineering Wing, 3<sup>rd</sup> floor, NBP, Head Office Building, I.I. Chundrigar Road Karachi, during office hours from today onward on any working day upto **17-04-2018** after paying a tender fee of Rs.1000/- (Non-refundable) in favor of Chief Engineer, National Bank of Pakistan.

The bids, prepared in accordance with the instructions in the bidding documents, must reach at the office of Chief Engineer, Engineering Wing, 3<sup>rd</sup> floor, NBP, Head Office Building, I.I. Chundrigar Road Karachi on or before **19-04-2018** at 11.30 hours. Technical Bids will be opened on the same day at 12.00 hours in the presence of tender opening committee and contractors, who wish to be participated. The date of opening of financial bids/ proposals will be communicated later. NBP reserves the right to reject all bids/ proposal at any time prior to be acceptance as per PPRA rule No.33.

An earnest money amounting to 2% of the bid amount in the shape of payment order / CDR or Bank Guarantee of scheduled bank in the favor of the Chief Engineer, NBP, must accompany with financial bid.
