#### **TERMS AND CONDITIONS FOR TENDER**

- 1) The Contractor Shall be responsible for smooth and satisfactory working of both the lifts proportionate deduction shall be made from the bills of the contractor for the period for which lift remain out of order.
- 2) The Contractor shall also have to deposit Rs 30,000/of Tender amount as earnest money in terms of payment order or Call Deposit Receipt (CDR)/ Bank Guarantee of scheduled Bank in favor of Divisional Head NBP Head Office, Karachi.
- 3) All Site support facilities i.e. fork lifter/crane etc will be arranged by the Contractor.
- 4) Any change in Govt. duties and taxes and currency devaluation will be on Contractor's part.
- 5) No previous quotation reference will be considered and accepted.
- 6) No escalation in tender amount on any account what so ever shall be claimed by the Contractor.
- 7) The Rates should be inclusive of all Govt. Taxes.
- 8) The NBP shall consider placement of orders for "Annual Maintenance Contract in respect of HVAC System including Boiler and ACs installed at NBP "on that Bidder whose offers have been found technically, commercially and financially acceptable.
- 9) PERIOD OF CONRACT: The contract will initially be valid for a period of one year from the date of award and may be extended further period subject to satisfactory performance of the firm and subject to the approval of the competent authority and mutually agreed terms and conditions.
- 10) In case the contractor falls to cope with the workload or does not render satisfactory services the contract awarded to him shall be cancelled forthwith without giving any notice or without assigning any reason whatsoever and his security deposit and payment due to him, if any, shall be forfeited. In this connection decision of the Divisional Head Engineering shall be final and binding on the contractor.
- 13) The Firm will supply all lubricants (made as per standards) necessary for this purpose. The Technical staff will maintain a logbook of the complaints received and rectified during the Period of contract. Should any eventuality arise, the NBP shall request for the services of the mechanic on Saturday/Sunday/Holidays and beyond office hours without payment of any additional remuneration. The contractor shall also keep stock of genuine spare parts

which may be required for replacement in the event of such parts becoming non-functional or defective, during the currency of the contract. The old part will be handed back to the NBP. In case of intermittent failures or repetitive problems due to improper diagnosis or repair, the machine will be treated as continuously out of order.

- 13) The contractor shall be responsible for handing over the Lifts (02) in working conditions to the Department at the end of the contract period. The cost of shortcomings, if any, shall be borne by the outgoing contractor.
- 14) The details of terms and conditions related to subject works as given in tender documents Should be strictly followed.
- 15) Registered with FBR, Sales Tax Department, Baluchistan Board of Revenue and any other Federal/Provincial or Local department which otherwise forbids conduct of tender works.
- 16) Never been blacklisted by any organization.
- 17) The bidders are advised to visit and examine the Site of Works i.e. Chiller, Boiler & Air conditioned at NBP City Branch Quetta and obtain all information themselves on their own responsibility that may be necessary for preparing the bid and entering into a contract for Operation & Maintenance of existing HVAC System.
