National Bank of Pakistan intends to undertake services of specialized company/Firm for Procurement of Decontamination and Air Purification Solution system for NBP Data Center, The interested reputable Firms/ companies who fulfills the following eligibility criteria may participate in bidding process.

Eligibility Criteria:

The eligibility criteria for selection of firm / company is submission of following information / documents:-

- 1. Name and address of the firm and branch offices in major cities of Pakistan (such as Karachi, Lahore, & Islamabad) with Tel/Fax numbers.
- 2. Company should have valid SECP's Certificate for Incorporation of company or FBR's Certification of company or Tax Payer status, showing that the company is in the business for the last 3 years.
- 3. Company should have sale volume of at least Rs. 10 Million in each year during last 3 years. A letter of Company's CFO or Senior Management confirming that the sale volume of company is at least 10 million in the last year.
- 4. An affidavit to the fact that the firm/ company has not been blacklisted by any Government agency in Pakistan for unsatisfactory past performance, corrupt, fraudulent or any other unethical business practice and also not involved in any kind of litigation cases.
- 5. List of similar Decontamination / Air Purification Solution/ system installed at Data Centers of minimum Five (05) financial institutions maintaining "G1" level environment with satisfactory performance Certificates from relevant clients of current date.
- 6. List of similar works in hand indicating their scope / cost and names of clients.
- 7. Details of litigation and arbitration cases, if any in which the firm has been involved during any works.
- 8. Company/ firm should have direct Partnership with the principle supplier and also must provide "Manufacturer Authorization Form" from principle supplier.
- 9. The Principle Manufacturer Company must be ISO 9001:2008 Certified.
- 10. Company has to provide minimum Five (05) CVs of their permanent Staff having skill and expertise in providing required services for this project.
- 11. Bankers certificate regarding financial standing for the last 03 years.
- 12. Any other information/document which could be considered essential for this EOI.
