

BID EVALUATION REPORT

Sealed tenders were invited from reputed generator sets supplying firms through press and NBP & PPRA websites for supply & installation of 20 KVA Prime diesel generator sets with ATS panels, canopies and power cabling etc. at 08 Nos. NBP branches of Regional Office, Multan as per PPRA rules. The tenders were received and opened on due date & time i.e 18-10-2011 at 1100 hours and were opened on same day publicly at 1130 hours in the presence of tender opening committee and contractors or their agents. Seven contractors purchased tender documents and four contractors participated in tendering. The tenders have been checked by Engineering Department. Following is the comparative statement of bids.
