Price of each of five (5) separate bidding document is Rs.1500/- (non-refundable) which will be paid in form of a pay order in favor of NBP. The Bidding documents will be issued after checking / scrutiny of following documents provided by the bidders;-

- Company Profile with complete detail of works in hand.
- Banker’s Certificate - credit worthiness of firm with Bank.
- NTN / GST Certificates. Name of Bidder must appear on Active Tax Payers List of FBR.
- After Sale Services, maintenance equipment and skilled manpower.
- Affidavit that the firm has never been blacklisted by any GOP /Semi Govt. or Autonomous Bodies. (on Non Judicial Stamp Paper of Rs. 50/-).
- List of any arbitration / dispute with any client present or past and nature thereof.
- List of generators of 20 KVA Prime Rating installed & above with name & contact number of clients.
- Copy of valid Dealership certificate from OEM. The OEM means Original Equipment Manufacturer of Generator which bidder will offer in the bid.
- Copy of valid Registration with PEC (with relevant Specialized Field).

The bids prepared in accordance with the instructions given in “**NBP Standard Bidding Document**” must reach at the office of undersigned on or before **July 19, 2021 at 11:30 a.m.** Bids will be opened on the same day (**i.e. July 19, 2021**) at **12:00 p.m.** publicly in the presence of Tender Opening Committee and the bidders representatives, who wish to be present at the time of tender opening. In case office remains closed for any reason/holiday, proceeding of bid opening will be conducted on next working day on same time & venue. Bidders are required to provide all documentary proof for technical evaluation with their respective proposals. Failure to comply with the aforesaid requirements will result in their disqualification. Technical and Financial bids will be submitted separately for each category. Bank reserves the right to accept or reject any or all tenders/bids at any stage as per PPRA rules.
