

INVITATION FOR BIDS

1. OPERATION & MAINTENANCE OF TWO ORONA PASSENGER LIFTS INSTALLED AT NBP, REGIONAL OFFICE, FAISALABAD.

1. The firm should have proven related experience in the field & interested are advised to submit below mention documents for technical examination and scrutiny during office hours at office of Wing Head (Central), Engineering Wing (Central), Lahore.
 - i. Company profile.
 - ii. Financial statements of the company for last two year.
 - iii. Complete list of employees, key Personnel, who will be involved in the project alongwith their names, qualifications and designations.
 - iv. Valid copy of National Tax Number and GST etc.
 - v. Detail of equipment machinery, tools, instruments available with the company.
 - vi. The firm should have relevant experience for operation / maintenance of Orona brand lifts. Further the firm should have capability for arrangement to provide spare parts like integrated card, breakers, ropes controls, relays etc. for use on urgency basis for trouble free operation of lifts.

 - viii. Copies of work orders and job completion certificates of similar works of operation & maintenance of Orona lifts should be provided.
2. Constructors who have finished minimum three similar nature of projects of worth not less than (1.0-1.5) Million Pak Rupees each during last five years are eligible to bid.
