- b) Firms should have an average annual turnover of at least 10 Million over the past three years and generally sound position. (Please provide audited financial statement of last three (03) years.
- c) Companies who have furnished two or more such furniture supplies of each worth of four (04) Million Pak Rupee or above during last five (5) years are eligible.
- d) An application on Company's letterhead is required for issuance of Bidding Documents.
- e) The firm has and independent legal existence as a valid registered company or a joint venture partnership for at least ten (10) years with specialization in supply of office furniture.
- f) The firm must have valid 'Quality Management' certification from an internationally accredited company. (ISO- 9001)
- g) Provincial / FBR Tax Registration Certificate of Income & Sales Tax. Name of Bidder must appear on Active Tax Payers List of FBR.
- h) A certificate from Bidder that they have never been declared blacklisted by any Government/Semi-Government or autonomous body. Litigation history.
- i) Valid PEC C-6 Registration.
