**GENERAL  
TERMS & CONDITIONS**

1. The Contractor shall assure complete safety and best workmanship. The work shall be carried out by experienced / trained technicians. Contractor is also not responsible for wear and tear of the equipment, however shall be responsible against any loss/injuries to his own staff.
2. All tools, meters, instruments required for service, testing and commissioning shall be arranged by Contractor.
3. Any dealing with IESCO/ Electric Inspector or with any Govt. / Semi Govt. Department shall be the responsibility of the Bank and all taxes, fee etc, shall be paid by the Bank.
4. Electric supply shut down, if required shall be arranged by the Bank.
5. The Contractor shall report to the Engineer in-charge EWN regarding defective/faulty equipment or part of equipment. The same shall be arranged by the Bank. However, on the other hand if the contractor is asked to arrange, he shall arrange and produce the cash memo or bills of the material purchased and shall claim 15% over and above the cost of material for replacement.
6. The contract shall be based on the following.

Overall checking of the equipment, generator and other systems for defects / faults and rectification of minor operational and running faults at site and bringing the system in operation.

7. Overall checking as detailed in scope of work. All the expenses shall be borne by the Bank for the replacement of parts modifications, defective equipment, pertaining to repair of defective parts/ equipment from outside including transportation.
8. Monthly bill shall be submitted and Bank shall release the payment within a week's time.
9. Seating space shall be provided by the Bank for safe custody of tools and instruments of the Contractor.
10. The contractor shall submit an estimate to the Bank for approval before carrying out any major repair necessary for clear and healthy operation of the system.
11. Rates should be inclusive of all Govt. Duties, Taxes & Insurances.
12. Conditional tenders will not be accepted.
13. Any change in Govt. duties & taxes and currency devaluation will be on bidder's part and no escalation for bid amount shall be claimed by the Contractor.
14. In case of any dispute arises during the execution of this contract, the decision of the Wing Head (North) / Bank Engineer will be final and binding upon the Contractors and without appeal.
