- 3. Affidavit that the firm has not been blacklisted in past by Govt. / Semi Govt. / Private Organizations.
- 4. Past performance of the constructors who have previously worked with NBP shall also be considered while issuing the bidding document.

All the interested bidders, who wish to participate in the bidding, must submit the documentary proof of above-mentioned eligibility criteria in the office of the Wing Head, Engineering Wing (Central), NBP, RHQ Building, Lahore, for verification by or before 20-01-2023. In case of noncompliance / indelibility the contractor firm will not be allowed to participate in the bidding process.
