A. INTRODUCTION

	3.3	 A Bidder may be ineligible if – a) he is declared bankrupt or, in the case of company or firm, insolvent. b) the bidder is blacklisted and hence debarred due to involvement in corrupt and fraudulent practices, or performance failure or due to breach of bid securing declaration. c) Convicted by a final judgment of any offence involving professional misconduct. d) Bidders shall provide evidence of their eligibility, proof of compliance with necessary legal requirements to carry out the contract effectively.

8. SPECIAL CONDITIONS OF CONTRACT (SCC)

The following Special Conditions of Contract shall supplement the General Conditions of Contract. Whenever there is a conflict, the provisions herein shall prevail over those in the General Conditions of Contract. The corresponding clause number of the GCC is indicated in parentheses.

1. Definitions (GCC Clause 1)

GCC 1.1 — The Procuring Agency is: National Bank of Pakistan

GCC 1.1 (p)—The Supplier is:

GCC 1.1 (q)—The tile of subject procurement is: Procurement of Office Furniture

2. Governing Language (GCC Clause 4)

GCC 4.1—The Governing Language shall be: English

3. Applicable Law (GCC Clause 5)

GCC 5.1-The applicable laws shall be Laws of: Pakistan

4. Country of Origin (GCC Clause 6)

GCC 6.1—Country of Origin is

5. Performance Guarantee (GCC Clause 10)

GCC 10.1—The amount of Performance Guarantee, as a percentage of the Contract Price, shall be: 2% of the Contract price (excluding taxes, duties)

GCC 10.4—the Performance Guarantee shall be retained for 30 days beyond the delivery period stipulated in the contract.

6. Inspections and Tests (GCC Clause 11)

GCC11.1— National Bank of Pakistan will inspect the deliverables to ascertain the quantity and specification aspects of deliverables and validate the documents / literature provided with Office Furniture.

7. Packing (GCC Clause 12)

GCC 12.2—The following SCC shall supplement GCC Clause 12.2:

The Goods shall be packed properly to withstand rough handling during transit and exposure to extreme temperatures during transit, and storage. Packing case size and weights shall take into account final destination of the Office Furniture.

8. Delivery

Office Furniture are to be delivered within 4 weeks of the signing of the contract. Part payment against part delivery is allowed. Delivery locations (within Pakistan) will be provided by NBP at the time of delivery.

9. Documents (GCC Clause 13)

Upon delivery of the Goods, Supplier shall notify National Bank of Pakistan and mail the following documents to the National Bank of Pakistan:

- i. One original plus four copies of the Supplier's invoice showing Goods' description, quantity, unit price, and total amount;
- ii. Delivery Challan
- iii. Warranty certificate;

The above documents shall be received by National Bank of Pakistan before the delivery of Office Furniture.

11. Payment (GCC Clause 17)

Payment for Goods and Services supplied shall be made in Pakistani Rupees, as follows: **On Delivery & Acceptance**: 100% of the delivered stock or Contract Price (as agreed in contract) shall be paid to the Supplier within thirty (30) days after the date of the acceptance certificate for the delivery issued by National Bank of Pakistan. Partial payment against part delivery is allowed.

12. Prices (GCC Clause 18)

GCC 18.1.1—Prices shall be fixed and shall not be adjusted.

13. Liquidated Damages (GCC Clause 25)

14. Resolution of Disputes (GCC Clause 29)

In the case of a dispute between the National Bank of Pakistan and the Supplier, the dispute shall be referred for arbitration in accordance with the Arbitration Act 1940.

- 1. If any dispute of any kind whatsoever shall arise between the National Bank of Pakistan and the Supplier in connection with or arising out of the Contract, including without prejudice to the generality of foregoing, any question regarding its existence, validity, termination and the execution of the Contract- whether during developing phase or after their completion and whether before or after the termination, abandonment or breach of the Contract the parties shall seek to resolve any such dispute or difference by mutual diligent negotiations in good faith within 7 (seven) days following a notice sent by one Party to the other Party in this regard.
- 2. At future of negotiation the dispute shall be resolved through mediation and mediator shall be appointed with the mutual consent of the both parties.
- 3. At the event of failure of mediation to resolve the dispute relating to this contract such dispute shall finally be resolved through binding Arbitration by sole arbitrator in accordance with Arbitration Act 1940. The arbitrator shall be appointed by mutual consent of the both parties. The Arbitration shall take place in Lahore and proceedings will be conducted in English language.

- 4. The cost of the mediation and arbitration shall be shared by the parties in equal proportion however both parties shall bear their own costs and lawyer's fees regarding their own participation in the mediation and arbitration. However, the Arbitrator may make an award of costs upon the conclusion of the arbitration making any party to the dispute liable to pay the costs of another' party to the dispute.
- 5. Arbitration proceedings as mentioned in the above clause regarding resolution of disputes may be commenced prior to, during or after delivery of goods.
- 6. Notwithstanding any reference to the arbitration herein, the parties shall continue to perform their respective obligations under the Contract unless they otherwise agree that the National Bank of Pakistan shall pay the Supplier any monies due to the Supplier.

16. Effective Contract Date (GCC Clause 3)

After having signed the contract, it shall come into force on the date of submission of Performance Security by the successful bidder.

17. NBP Terms & Conditions

GENERAL TERMS & CONDITIONS

FURNITURE WORKS

- The contractor will be responsible to obtain approval of samples of all materials, fittings, fixtures, MDF, lamination sheet, fabric/leatherite/buff neubic leather. locks, key board try etc. to be used in furniture works and furniture items before executing of works.
- It is the responsibility of the vendor to visit NBP Corporate centers situated at M. M. Alam Road Lahore /G-5 building Islamabad to check the model furniture in terms of quality & specifications regarding all types of material, workmanship, polish including hard ware, etc.
- The work will be strictly executed as per terms, conditions & specifications outlined in the tender documents except as may be subsequently amended by the Chief Engineer (North).
- The contractor will be responsible for carrying out the works in true and excellence workmanship.
- Substandard and poor quality works shall not be accepted at any cost & under any circumstances.
- During the execution of work, no minor / major discrepancies should be left otherwise no payment shall be release against respective items.
- 7. The work will be completed in specified stipulated time period. In case of delay a penalty of 0.10% per day will be imposed by the Bank upto 10% of contract value and the Bank reserve the right to recover the penalty from contractor running bills.
- No escalation in rates shall be paid by the Bank at any case.
- All tools require for works will be arranged by the contractor.
- No bill of the contractor will be paid without proper standards works. The decision of the Chief Engineer / Engineer In charge will be final and binding.
- The contractor will be responsible to carry out the works during working hours and beyond working hours



- 12. The security measures will be managed by the contactor while execution of work, during working hours or beyond working hours.
 - The rates for works should be inclusive all kind of taxes like sale tax, income tax, import duties / insurance, bank guarantee etc.
 - The payment shall be made as per actual measurements of works to be done / supplied at site.
 - 15. Rates should be quoted on item rate basis as detail given in the BOQ.
 - In case of any dispute arising during the execution of this contract the decision of the Chief Engineer / Divisional Head will be final and binding upon the Contract without appeal.
 - During execution of work contractor is responsible for the branch/office fixture, fittings, furniture and any damage to them is the responsibility of Contractor to be indemnified to Bank at actual cost.
 - Any change in govt. taxes/duties and currency devaluation will be on contractor account. Bank shall not entertain any claim what so ever.
 - 19. No previous tender / quotation reference will be considered and accepted.
 - No escalation in tender amount on any account what so ever shall be claimed by the contractor / supplier.
 - 21. The payment shall be released as per actual scope of work done and satisfactory supply and after providing photographs (Hard Copy) of all furniture items along with receiving from respective branch/office.
 - .22. Bank reserves the right to reject any tender or part thereof without assigning any reason.
 - 23. Completion time of whole works with free of defects will be 30 days.
