Lot-2: Supply of Printed Material (Printed Stationery) for Lahore. PKR 4,600,000.00/-

Lot-3: Supply of Printed Material (Printed Stationery) for Islamabad. PKR 6,500,000.00/-

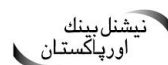
